This indenture made the ninth day of June 1774 between John Vestal of the county of Berkeley and colony of Virginia and Ann his wife of the one part and John Lafever of the county of Philadelphia and province of Pennsylvania of the other part - Witnesseth that for and in consideration of the sum of five shillings current money of Virginia to the said John Vestal in hand paid by the said John Lafever as or before the sealing & delivery of these presents the receipt whereof he doth hereby acknowledge they the said John Vestal & Ann his wife have granted demised and to farm let unto the said John Lafever and by these presents do grant demise and to farm let unto the said John Lafever all that tract or parcel of land containing 145 acres lying and being in the county of Loudoun the north west side of Goose Creek on a branch thereof called Tuscarorah alias Secolines branch mentioned in a certain patent granted to a certain Jacob Binks under the Great Seal of the Colony of Virginia bearing date 1728 and sold and conveyed by Patrick Laferty and Prudence his wife the surviving heir and daughter to the said Jacob Binks & conveyed by them to John Nevil who conveyed the same to the said John Vestal by deeds of lease & release bearing date the 18th & 19th day of January 1769 and is bounded as followeth Beginning at a small red oak on the side of the said branch called Tuscarora alias Secolins and extending thence S 35 W 160 poles to a large white oak thence S 65 W 204 poles to a white oak on the side of the aforesaid branch thence N 60 W crossing the said branch 30 poles to a small red oak on the foot of a hill thence N 35 E 157 poles to a white oak standing about 30 poles from the said branch on the north west side thereof thence down the said branch N 71 E 225 poles to the beginning containing 145 acres also a certain tract or parcel of land containing 76 acres lying & being in the said county of Loudoun adjoining to the above mentioned tract mentioned in a certain deed granted to a certain Abraham Lindsay from the Proprietors office bearing date July 1745 and conveyed from him the said Abraham Lindsey to John Nevil by deed sealed & release bearing date the 25th & 26th day of July 1763 and was conveyed by the said Nevil to the said Vestal by deed of lease & release bearing date the 18th & 19th days of January 1769 and is bounded as followeth Beginning at a white oak corner to Col. Landon Carter, thence with his line S 6 E 17 poles to a red oak on Goose Creek side thence crossing the creek N 78 E 73 poles to 2 white oaks in the head of a valley, thence N 28 E 25 poles to a white oak & hickory, thence N 6 E leaving the said creek at 80 poles stil on 158 poles to a white oak in a glaid thence S 51 W 33 poles to a red oak corner to another tract of the aforesaid Carter & Jacob Binks, then with Binks line N 81 W 26 poles to a white oak corner to Binks line thence S 18 W 170 poles to the beginning containing 76 acres also all that tract or parcel of land situate lying and being in the said county of Loudoun being part of a greater tract formerly taken up by William Berry and by the said Berry conveyed to a certain Philip Feezel [or Teezel?] who conveyed the same unto the said John Vestal by deed of lease & release bearing date the 10th & 11th day of October 1770 and bounded as followeth Beginning at a black oak marked PR thence N 75 W 104 poles to a white box oak thence S 18 E 26 poles to a white oak marked LC corner to Carter thence with the said Carter's line S 20 W 53 poles to a dead white oak at the corner of Feezels fence said to be corner to Carter thence with another of Carters lines S 41 W 37 poles to Binks his line then with the same N 71 ½ E 159 poles thence N 45 W 10 poles to a small hickory on the side of Seconels branch thence N 15 E 22 poles 13 links to the Beginning containing as by survey thereof made by George West

transferring of uses into possession to the said John Lafever may be in the more full and actual
possession of the said premesses and thereby be enabled the better to accept and to take a grant and
release of the reversion and inheritance thereof to him and his heirs to the only proper use and? of
